Sheriff Povero Social Host Presentation	Discussion		
	<ul style="list-style-type: none"> • The Sheriff applauded our efforts with regards to substance use in our county. Ontario County's Social Host Law was passed in 2009 after the Sheriff worked with the county attorney, district attorney, and other community stakeholders for input. He firmly believes that if used appropriately that the Social Host Law has helped to fill a void and reduce the behavior in his county. They usually have 20-25 cases per year. There is a three step consequence to their Social Host Law with each step building upon the one before it. The first step is a violation of the law with a fine and 		

	<p>possible jail time. Violators are also required to complete an alcohol recognition program. They have SRO's in each district in Ontario County and the kids help "sell" the law to their parents. They are trying to promote a safe message along with their STOP DWI Coordinator. With the help of the local movie theaters they played a short clip about Social Host before movies in order to get the word out. They have seen the effects of their law with a change in behavior. There will be a change in state law occurring on October 1, 2018 and 2019 respectively that 16 and 17 years olds will no longer be tried as adults. They are currently looking at how the change in state law will affect their law currently on the books.
