Pre-Trial Release Terms with Electronic Monitoring

I, _____, understand that I have been released to the supervision of the Schuyler County Pre-Trial Release Program (PTR) to include Electronic Monitoring (EM). I agree to comply with the following Terms and Conditions:

- 1. I will report as directed to the Schuyler County Probation Department to meet with the Pre-Trial Release Officer and agree to allow Probation to install and maintain an Electronic Monitoring device on my person as ordered by the court.
2. I will notify the Probation Department of any change of address or telephone number within 24 hrs.
3. I will be present at every Court Appearance, as directed by the Court and/or the Pre-Trial Release Officer.
4. I will Observe and obey all Court Orders, the Laws of the State of New York, the Laws of the United States of America, and the Laws and Ordinances of any Municipal Division thereof.
5. If I have contact with any Police Agency or Officer, I will notify the Pre-Trial Release Officer within 24 Hours.
6. I will call my Pre-Trial Release Officer immediately, if I should have any questions with regard to my next Court appearance or any other questions relating to my release conditions or Electronic Monitoring.
7. I Cannot possess, purchase, or consume illicit drugs or mind altering substances of any kind without a valid prescription from a licensed prescriber to be taken as prescribed/intended; cannot possess drug paraphernalia.
8. I will Submit to periodic tests to determine the use of restricted, illicit, or mind altering substances, including alcohol upon the specific request of the Court and as conducted or directed by the Probation Department.
9. I agree to properly wear and maintain said Electronic Monitoring (EM) device by charging it regularly, not damaging it or removing it from my body or impeding with its functions in any way.
10. I agree to abide by inclusion and exclusion zones as established and directed by the Court and/or Probation.
11. I will contact the Probation Department immediately within 24 hrs. if the device is compromised or fails in anyway.
12. My Electronic Monitoring requirement will expire after 60 days and may be renewed by the Court - CPL 510.40 (4)(d).
